- No personal checks accepted. Note: Only ONE DEADLINE.
- Entry must be printed or typed. Entries that are not legible will be returned. Only one team entry per form.
- Group entries must include USTA member ID number of each participant and a group/organization membership ID number if applicable.
- Group entries must include the group roster showing all members' names, ages (as of 12/31/10), birthdates and name/division of other groups the member will compete it.
- All participants must sign a waiver of liability to participate. Group entries should include signed waiver for all members who are not also participating in the individual competition.
- Pre Order Programs on this form. Pre Order Programs \$10 (on site \$15). There will be NO Pre Order T-shirts. T-shirts will be available for purchase at the event.  
Group directors: Make your athletes/parents aware of the cost of pre order/on site programs. Have them pre order on individual entry form or through you on this group form.
- Please note restriction for both Festival of the Future and National Championship Groups Competition:
  - \* Twirling Teams who enter the Advanced level of competition at the National Championships may not enter the Beginner or Intermediate level of competition at the Festival of the Future Championships in the Twirling Team event.
  - \* Dance Twirl Teams who enter the Advanced level of competition at the National Championships may not enter the Beginner or Intermediate level of competition at the Festival of the Future Championships in the Dance Twirl Team event.
  - \* Twirling Teams who enter the Festival of the Future Championships may enter in both Beginner and Intermediate level of competition (if eligible), but they may not enter the Advanced level of the competition at the National Championships in the Twirling Team event.
  - \* Dance Twirl Teams who enter the Festival of the Future Championships may enter in both Beginner and Intermediate level of competition (if eligible), but they may not enter the Advanced level of the competition at the National Championships in the Dance Twirl event.
