Team USA Selected for World Baton Twirling Championships

A talented team of 20 women and five men has been selected to represent the United States at the 34th World Baton Twirling Championships, to be held August 2-5, 2018, at the Osceola Heritage Park Silver Spur Arena in Kissimmee, Florida. Nearly 200 of the world's best sport baton twirlers from 17 countries, including the United States, Canada, France, Italy and Japan, will compete for bronze, silver and gold medals in the twirling equivalent of the Olympic Games.

Team USA athletes were selected

during the prestigious U.S. Trials Competition, held March 24-25 in Shelbyville, Indiana. The Junior Women, Senior Women and Senior Men will compete for final placement at the U.S. National Baton Twirling Championships, July 8-14, in Jacksonville, Florida.

In the Junior Men's division, USTA ruled that competitor Brandon Ellis, who achieved a score less than one point away from the qualifying score, will be given the opportunity to re-compete at the U.S. National Baton Twirling Championships to achieve the

qualifying score necessary to represent the U.S. at the World Baton Twirling Championships.

Team USA will represent the U.S. in Men's and Women's individual Freestyle, Pairs and Team at the World Baton Twirling Championships.

The U.S. Trials and the U.S. National Baton Twirling Championships are sponsored by the U.S. Twirling Association (USTA). For more information about these events, USTA and the sport of baton twirling, visit www.ustwirling.com.


"Being the first feature twirler at CU in 20 years has been a life changing experience," said Turnbull, a sophomore from Clovis, Calif. "Not only has CU accepted me but all of Colorado has as well. Every time I perform in my CU costume, everyone is very welcoming and always excited to see my batons fly up in the air."

Turnbull, who is studying psychology, is a high profile twirler who is helping pave the way for a new generation of scholastic twirlers in the Centennial

state. For the first time in decades, you'll find Colorado middle and high school baton twirlers on the football field, in front of the marching band, performing with school spirit squads and sharing the sport of baton twirling with a larger public audience.

"I hadn't seen a baton twirler in a long time and I thought it would be a wonderful added element and it was!" said Jason Mabrey, band director at Eaglecrest High School in Centennial, Colo. "It was something out of the ordinary. I received many comments on it throughout the season. People liked it."

Mabrey took a chance and added a twirler to his marching band this year for the first time in school history, after Jolina Andrews, an 8th-grader at a middle school that feeds into Eaglecrest High School, inquired about twirling opportunities. Andrews is thrilled to be the inaugural twirler at EHS. During her first year as part of the EHS Raptor Regiment, she performed at parades, pep rallies and football games. Eaglecrest went to the Colorado 5A Football Championships, which were held at Mile High Stadium where the Denver Broncos play. Eaglecrest also performed at a Colorado State University-Pueblo football game.

Andrews says it has been an honor to represent the high school she will attend next year.

"It's been lots of fun meeting people and contributing to school spirit," she said.

Emma Alexander, a freshman and the first-ever twirler at Cherokee Trail High School in Aurora, Colo., agrees.

"The first time the student section saw me twirl, they went wild, chanting 'twirler!' and even chanting my name. That moment is one I will never forget," said Alexander, who twirls with the pep band, since CTHS doesn't have a marching band.

Andrews and Alexander are among more than a dozen athletes who are now twirling for their Colorado middle and high schools after a dearth that lasted at least two decades. Some people attribute the change to increased awareness of scholastic twirling that has come via the internet and organizations including USTA, which highlights middle, high school and college twirlers on its website and social media channels, as well as entities such as CollegeMarching.com, which includes twirlers in its online coverage of college marching bands.

Regardless of the reasons for the change, Colorado twirlers are thrilled to have the opportunity to share their sport and represent their schools.

"The best thing about twirling for my high school is that I get to showcase my sport and be a part of high school team," said James Koehler, a senior at Windsor High School, which has a team of four twirlers and is argu-

ably the best scholastic twirling group in Colorado. Koehler says it can be a challenge to be a twirler at a school or in a state where people aren't always familiar with the sport.

"Persevere," Koehler said. "Not all schools know what to do with a twirler. Sell it. We had to in Windsor. Practice a lot and plan to be part of a team of great people."

Koehler and his fellow twirlers had the opportunity to perform at a powerful national event.

"My junior year we went to the 75th Anniversary of the bombing of Pearl Harbor and performed in a parade and performance event," Koehler recalled. "It was humbling, yet an honor. And we took first out of 15 bands!"

Audrey Schultz, a junior at Windsor High School and one of Koehler's twirling teammates, agrees that travel is one of the benefits of scholastic twirling. Another is the opportunity to share the sport of baton twirling with a broader audience.

"Twirling for my high school finally shows all of my friends what I have

been working towards for the past nine years," Schultz said. She encourages any twirler who has an interest in scholastic twirling to pursue the opportunity.

"My advice to twirlers who want to twirl for their school is don't be nervous," Schultz said. I know from experience that freaking out and getting nervous does no good."

"Remember to work hard and believe in yourself," added Alexa Lytle,

a sophomore at Cherry Creek High School in Greenwood Village, Colo., who twirls with senior Jessica Cantor.

"Be proud of what you do and always do your best," said Eaglecrest's Andrews.


CU's Turnbull summed it up this way: "Keep on twirling and to always push yourself to be the best twirler and person you can be!"

USTA and Benefactor Foundation welcome new coordinator

Cassandra Olivos, or Cassie for short, is looking forward to returning to her roots.

The Long Island native has been involved in baton twirling for most of her life. She grew up in Mineola where she started twirling at age five as a member of the *Golden Showstoppers*. Over the years, her love for all things twirling continued to grow.

"Twirling and color guard were my whole life in high school," said Olivos, who attended Mineola High School. "I loved to perform, dance and obviously, twirl things — batons, flags, rifles, sabres!"

Olivos says her twirling teammates were among her best friends growing up and some of her fondest memories are of their trips to Nationals in 2005, 2006, 2007 and 2008. Even though some of them were in college by then, they promised to twirl together until their youngest teammate graduated from high school.

"Those friendships were everything," Olivos recalls. "Though life has pulled us in different directions, with some of us living in different states, we still try to meet up annually and we pick up right where we left off!"

After retiring from competitive twirling, Olivos became a Certi-

fied Level I coach, working with her younger sister and other members of the Golden Showstoppers. Then college and career became her primary focus. Olivos studied public relations and advertising at New York Institute of Technology, earning a Bachelor of Fine Arts degree in Communication Arts. She followed that with a Master of Science degree in International Communications from St. John's University.

Along the way, Olivos discovered her passion for social media marketing on a local and global scale. Even with that workload, Olivos has reached a point in her life where she wants to give back to the sport that gave her so much growing up.

"Twirling was a huge influence on me, not just as an athlete, but as a person," Olivos said.

She's looking forward to using her professional expertise and twirling background as coordinator of the USTA Benefactor Foundation, a 501(c)(3) notfor-profit organization that supports the growth and development of USTA and the programs and services it provides to its athletes and other members.

The Benefactor Foundation was established in 1997 under the guidance

Meet USTA's Council Presidents, Part 7



Amby Darr Taylor, Southeast Region Council President

Enjoy this Q&A with Amby Darr Taylor, president of the Southeast Regional Council.

How did you initially get involved in baton twirling?

I got my first baton because I twirled the "sticks" that we used in the windows of our old farm house. My dad was really tired of taking splinters out of my fingers, so I got my first baton. Once I got my first baton, I started with a local group at the age of nine and the rest is history. Actually, many years after beginning my twirling career, my dad told me that he always wanted one of his daughters (I'm the youngest of six children—four girls, two boys) to twirl. (He wanted me to

wear the short boots with the tassels!) Luckily, my twirling allowed me to attend East Carolina University on an out-of-state tuition waiver scholarship between the School of Music and the Athletic Department. As the youngest of six, this paid for half of my college tuition and allowed me to receive my teaching degree. I was the first one in my family to go to college, so it was really important to me that I was able to help pay for part of my tuition.

How have you been involved in twirling over the years....as an athlete, coach, judge, contest director, council member, USTA roles, etc.?

I became a USTA member in 1973 (so I've been a USTA member for 45 years!!) I competed at local competitions from the age of 9-12 (Growing up in Virginia, there were competitions every weekend in VA, MD, and WV. I attended my first regional competition, Northeast Regionals, in 1974 when I was 12, then my first Nationals at the age of 13, also in 1974. My birthday is in July, so I competed at one age all year, but went up an age for Nation-

als. Nationals were in August when I competed. I competed at the national level from 1974 to 1980. I became a judge in 1981 and began judging at Nationals in 1985. Those dates mean I've been judging for 37 years! I have been a member of the U.S. Technical Department since 1988, so I originally became the Southeast Regional representative. As our council grew, thanks to Karen Cammer for coming to SER years ago, to help us set-up our regional council, we began working together to hold the regional championships each year.

When did you become your council president?

To be honest, I can't remember when I became president. I do know that I was the vice-president for the region while John Chamberlain was president. Once he became president of USTA's Board of Directors, he talked me into becoming president.

Why were you willing to take on the presidency?

Behind John's leadership I was ready to become president in order to continue the hard work that had been done to

make our region successful.

Tell me about your council – how many members, what types of events or activities it sponsors, special things it does, etc.

Our region is large in land area, but most of the members are concentrated in Florida and Tennessee. With that being the case, we alternate years to

hold our Regional Championships. In even-numbered years we hold our regionals in Florida and in odd-numbered years, we hold regionals at Loftis Middle School in Hixson, Tenn. We are very fortunate to have the facility in Hixson. Because of the relationship with Tracy Hughes and United Twirling, we get this facility free of charge, except to pay the custodial staff to clean after the three-day competition.

In Florida, we are lucky to have Tessah Ceballos because she gets sports grants for us to get facilities at a reduced rate, as well as some help with hotels, etc. We are very happy to have Alabama becoming active in our council and we really look forward to adding Alabama to our rotation very soon. Each year after our Saturday competition, we hold our regional meeting.

We are also available to our members through email as well as setting up our USTA SER Council Facebook page, thanks to Tricia Terrell and Amy Trujillo. To be perfectly honest, being the SER President is really a team effort! Vice President Kelly Mullins, Secretary Amy Trujillo, Treasurer Tracy Hughes and Lori Marcus, Tessah Ivey Ceballos and John Chamberlain are all vital pieces of the puzzle. Whenever our National Championships are held in our region, the SER Council

helps with monetary donations as well as volunteer manpower. We are very excited that in 2018 our 60th Anniversary U.S. National Championships are being held in Jacksonville, Fla., and the 2018 WBTF World Championships are being held in Kissimmee, Fla.!

What is the biggest challenge and the biggest reward of being your council president?

The biggest challenge is being able to keep costs, including travel, entry fees, etc., down each year in order to hold a successful championships. The biggest reward to me is having an amazing team because I'll tell you, IT'S NOT ME....IT'S THE SER TEAM! Our teamwork is what makes us successful! Really, I'm very lucky to be the SER Council president because it's not me as an individual....it's the team—the entire council!

What are the qualities of a successful council president?

As I've stated before, being president of my council is an honor, but if I didn't have my team, I wouldn't be able to be president.
